Every 5 years, after IMPLAN has incorporated the newest BEA Benchmark I-O tables and a new industry scheme, we re-estimate all IMPLAN data years from 2001 forward to a) incorporate non-lagged revised raw data, incorporate any methodological changes adopted across the previous 5 years, and c) put all data years into the same, new industry scheme.
